**Preamble:**

Government of India has launched Atal Mission for Rejuvenation and Urban Transformation 2.0 (AMRUT 2.0). AMRUT 2.0 is a step towards Aatma Nirbhar Bharat with aim of making the cities 'water secure' and providing functional water tap connections to all households. One of the admissible components is 24\*7 water supply under AMRUT 2.0. All 500 AMRUT Cities are mandated to implement 24\*7 Water supply in at least one ward or one DMA ( District Metering Areas) with 2000 households.

Ministry of Housing and Urban affairs has constituted National Task Force (NTF) on 24\*7 water supply system for under taking capacity building of State and ULBs to disseminate knowledge, best practices and guideline on 24\*7 water supply to assist in planning, design and implementation of project under AMRUT 2.0. The States/UTS are advised to set up the State Level Task Force (STF) at AMRUT cities for continuous interaction with the NTF for Planning, Design and implementation of 24\*7 water supply projects during the AMRUT 2.0.

After careful consideration of the above facts and as per GUDM's proposal on Read (1) to constitute State Level Task Force (STF) for 24\*7 water supply in ALL AMRUT Cities under AMRUT 2.0 Mission, it is hereby decided as under.
