## Preface:

Central Government has launched "Atal Mission for Rejuvenation and Urban Transformation (AMRUT) 2.0" to provide basic infrastructure facilities such as Water Supply (all 164 ULBs + Ahmedabad Cantonment Board), Sewerage (all 31 AMRUT cities), Water body Rejuvenation (all 164 ULBs + Ahmedabad Cantonment Board) and Parks/Garden (all 164 ULBs + Ahmedabad Cantonment Board) to all the Urban Local Bodies (ULBs) of the state. Gujarat Urban Development Mission has been designated as a Nodal agency for implementation of AMRUT 2.0 projects.

GUDM has issued the order no. GUDM/AMRUT 2.0/DPR & Tender Preparation/1555, dated 17/06/2022 for preparation of Detail Project Report under AMRUT 2.0 till the new empanelment is not being finalized from the State Mission Director office.

With reference no. 1, State Mission Director office has appointed 3 empanelled consultant for the preparation of detail project report of Water Supply/Sewerage/Water body Rejuvenation/Parks & Green Spaces under AMRUT 2.0 & Other Central/State funded schemes on dated 29/10/2022.

The order no. GUDM/AMRUT 2.0/DPR & Tender Preparation/1555, dated 17/06/2022 is therefore treated as null and void. The previous order shall be non-effective after the date of 29/10/2022 and consider the empanelment order no. GUDM/Tech/AMRUT 2.0/2794, dated 29/10/2022 only. The remaining works/projects for which work order has not been assigned to any consultant for Tranche 1, Amrit Sarovar and Tranche 2 projects before 29/10/2022, then it must be assigned to newly appointed consultant only (Reference no. 1).

All the Chief Officers are hereby informed that ULBs shall not issue any work order to any consultant other than this newly empanelment consultant (Reference no. 1) under AMRUT 2.0 scheme to avoid audit objections regarding duplication of work and payment.
